Customized, Structured Curriculum


Our program delivers curriculum over six months, giving you time to transfer knowledge into actionable business plans while you're working on your prototype.

By keeping each cohort to 10 companies, interactions are highly collaborative. While instructors teach cohorts, the cohorts also learn from each other through sharing their experiences.

Superior Financial Support

Start-up funding is hard to secure. Companies selected to participate in Luminate each receive a \$100,000 convertible note investment at the beginning of the program that culminates in Demo Day, where one team will receive \$1 million in follow-on funding, with an additional \$1 million available to other competition finalists.

PARTICIPATION CRITERIA

Luminate is a highly competitive, cohort-based accelerator program that runs annually. To qualify, companies must be incorporated, in the early or start-up stage, and have a team of at least two full-time members who are committed to commercializing their OPI technologies. Technologies have to be proven at least at the lab scale.
